SPRINT FIDELIS LEADS and OTHER RECALLS

Many of you will have now been notified if you have one of these leads implanted. These leads are at risk of possible early breakdown and we are keeping a very close eye on them. We have ways and means of following them up to ensure that they are functioning so we are trying to minimise the risk and worry to all of you who have one of them.

We will keep you updated of any further developments with this problem.

I would like to re-assure you all that we keep a very close watch for any potential problems and that if we see any sign of something out of the ordinary we report it to both the manufacturer and to the MHRA which is the UK regulatory affairs body. They monitor all failures/problems with devices and leads very closely and liaise with the NHS and the manufacturers to make sure that all patients are as safe as they can be.

Because of the nature of implantable devices and leads, there will unfortunately always be some failures and every manufacturer has had some over the years. This is despite the most stringent quality control and checking of all new devices coming to the market. Some faults are time dependent and are not picked up until time has elapsed.

This is however a very rare event and most devices and leads will happily last their allotted time with no problems at all.

The overall failure rate for most systems is <0.1% which is tiny if you think of the total numbers implanted.

NEWS FOR DRIVERS

The rules on driving for ICD patients change quite often. To get the most up-to-date information you should either contact Sue Jones at the Pacing Clinic or phone DVLA on 0870 600 0301 or go to the official website:

Another change has been made to the processing of licences for ICD drivers.

Bottom line is this:

1.If you have had an ICD implanted because of a previous sustained, serious cardiac arrhythmia eg VT, VF or Cardiac arrest then you must not drive for 6 months after implant and MUST notify the DVLA.

You still have to fill in forms - as will your implanting centre - <u>BUT you will now get a regular</u> licence re-issued provided that you sign one of the forms "DECLARATION OF TRUST" that you will notify the DVLA if you ever have a dangerous rhythm and treatment from your ICD that causes loss of **CONSCIOUSNESS, DIZZINESS OR ANY INCAPACITY.**

A ONE WEEK ONLY driving ban NOW applies after:

• Routine Box change only

And a ONE MONTH ban applies after:

- A lead change or
- Change in anti-arrhythmic drug therapy
- Or if we have had to induce an arrhythmia at the procedure

2. If you have had an ICD implanted for prophylactic reasons e.g. you have never had a life threatening rhythm but you may be at high risk because of a genetic/family connection then you DO NOT NEED TO NOTIFY THE DVLA on implant and you are only stopped from driving for 1 month.

You will however be required to notify them if at any time you DO have a dangerous rhythm.

3. You should be aware that if you do have frequent shocks which cause dizziness or incapacity or loss of consciousness and the rhythm that is causing these cannot be satisfactorily controlled by drugs then the DVLA may issue a longer or permanent ban. This does not happen very often but can in some circumstances.

THIS YEAR'S AGM

The BackUp AGM for 2007 was held on Saturday 29 September at Epsom Hospital. We had an excellent turn out and we were delighted to meet many new patients as well as see lots of familiar faces again. Our AGM business was brief but nonetheless important. Sue Jones introduced the committee members who were there – Louise Power, Paula Jones and Stephanie Cruikshank. Many of you will know Paula who, of course works with Sue in the clinic and Stephanie as she works as an Arrhythmia Nurse Specialist at St George's. Stephanie is also an ICD patient herself. Our other current committee member is Tina Amiss who was on holiday. Louise and Tina are both ICD patients.

Louise gave details of BackUp's accounts, which our Treasurer, Derek Jones, kindly prepares for us. (Thank you, Derek!). At present we have about £7,000 in the bank so as the account is healthy, we are not seeking contributions from members at present. Our funds mainly come from donations from the ICD Manufacturers (Guidant and Medtronic) and from the DVLA fees which the staff at St George's generously donate.

Louise also put out a plea for new committee members as, sadly for us - but lovely for them – Simon and Gill who have been involved with Backup from the very beginning have moved to Scotland For those of you who have only recently joined, Simon was the editor of our newsletter and Gill ran the Partners Support Group.

We had a very full agenda with five speakers. Each speaker covered a very different topic but they were all equally informative and enjoyable. Trudie Lobban from the Arrhythmia Alliance gave a very interesting talk about the AA and how it got started - literally from her garage! Trudie's daughter has syncope and Trudie described how she had been approached by her daughter's consultant to speak to another patient. From that conversation she realised the importance of sharing information and help so she started a support charity called STARS. Gradually, Trudie realised that if STARS joined forces with other similar organisations they could make a greater impact creating awareness in both the medical profession and the general public. STARS, therefore, joined with the CMA, SADS and what was then called National ICD Patients Support Group, of which our group (BackUp) was a part. These charities then teamed up with HRUK, who represent medical professionals working with Arrhythmias and the whole organisation snowballed from there. One of the AA's greatest achievements was to help get a new chapter on Arrhythmia added to the National Service Framework (NSF) for Cardiology. You may already know that there is now an Arrhythmia Awareness week each year.
